Section 1711.06 (Membership in County Society)
Members of a county agricultural society must be residents
of the county in which it is organized. The annual membership
fee shall be fixed by each society or its board of directors and
paid to its secretary or treasurer as its bylaws direct. A
printed certificate of membership shall be issued from a
book in which duplicate stubs of the same are properly
filled out and preserved. All such certificates shall be
numbered consecutively.

No person shall pay for or secure more than one such membership, and that membership shall be for himself. A list of the members of each society shall be kept in the office of the secretary of the society and shall be open to public inspection at all times so as to afford convenient information to any resident of the county.

Monroe County Agricultural Society Constitution

Section 1. The Society shall be known as The Monroe County Agricultural

Article II - Object

Section 1. The object of this Society shall be to promote and encourage agricultural industry, science, art and other interests of Monroe County which the Board

deems proper and in the best interests of the community. Article III - Membership

Section 1. Any resident of Monroe County, 18 years of age by the second Thursday in October, may become a member of this Society by purchasing a membership certificate (ticket).

Section 2. Membership certificates will be on sale December 15 for the following calendar year and remain on sale until Monday, 9 p.m. of the current years fair.

- Section 3. No membership shall be issued to corporations, organizations, partnerships or firms.
- Section 4. Membership certificates (tickets) shall admit member to the annual fair anytime and voting privilege at the annual elections of Directors.
- Section 5. Membership fee, time and place of sale of membership certificates (tickets) will be determined by the Board of Directors during their re-organization
- meeting held on the second Thursday in October.
- Article IV Board of Directors
- Section 1. The management shall consist of a board of 18 members, who shall be
- elected for a term of three years and the terms so arranged so that one-third of the
- members shall expire annually. Section 2. Any vacancy caused by death, resignation, removal from office, or other causes may be filed by the Board until the next annual election, when a
- director shall be elected for the unexpired term. Article V - Election
- Section 1. The annual election of the Board of Directors will be held in the kitchen of the Henri Coulson Building on Friday of each years fair from 3 until 7
- Section 2. The said election shall be by ballot. Ballots must be marked with an X opposite the name of each candidate voted for, otherwise they will not be count-
- Section 3. Only persons holding memberships certificates on the date and hour of
- the election may vote.
- Section 4. Members of the society must declare their candidacy for the office of Director of the Society by filing with the Secretary of the Society, a petition signed by ten or more members of the society, who are residents of the County in
- which the Society is organized, at least seven days before the annual elections of Directors is held. Only regularly nominated candidates who have met the filing requirements will be eligible for election as a director. Section 5. The term of the term of retiring Directors elect shall expire and that of
- the successors are elected and qualified. Section 6. In the case of a tie vote on a referendum for a constitutional amend-
- ment, provision, by-law, or other issue, the amendment, provision or by-law shall be deemed defeated. Section 7. In the case of a tie in an election for a Director, the winner shall be
- determined by toss of a coin.
- Terms of Office for Society and Officers, and Conduct of Election
- (A) Each Society Shall
- Elect Directors for three year terms.
- (2) Arrange the terms of the office of the Director to the extent that the number of Directors will permit - so that the terms of one-third of the members will expire
- (3) Establish the term of office of the retiring Director so that their term will

November each year thereafter, beginning in 1996

- expire and those of the Directors elect shall begin, not later than the first Saturday in January, 1997 and not later than the thirtieth day November each year begin-
- (4) Establish the date of the annual election of Directors so not to be held later than the first Saturday in December, 1995 and not later than the fifteenth day of
- (B) Any Society may:
- (1) Specify in its constitution the numbers of terms any person may serve as a member of the Board of Directors.
- (2) Provide in the constitution or by-laws for honorary Directors with no voting
- Article VI Duties of Officers
- Section 1. It shall be the duty of the President to preside at all meetings of the Board, to appoint committees, countersign all orders for the disbursement of funds, and to perform such other duties as are determined by the Board. Section 2. It shall be the duty of the Vice President to assume all the duties of the

President in the event of his absence or vacancy of office and to perform such other duties as are determined by the Board.

Section 3. It shall be the duty of the Secretary to:

- (1) Keep a list of all members of the Society.
- (2) Keep accurately a record of all proceedings of the Society and the Board. (3) Notify all members of the Board of the time and place of all special meetings.
- (4) Give the members of the Society notice of the time and place of the annual election of the board of Directors and the Annual Meeting of the membership.
- (5) Keep strict account of all money that may come into the hands and pay

the same over to the Treasurer and take his receipts therefore. Section 4. It shall be the duty of Treasurer to:

- (1) Keep a correct itemized account of all receipts and expenditures of money. (2) Make out the annual report to the Ohio Department of Agriculture.
- (3) Perform such other duties as are determined by the Board.
- Article VIII Rates

The Board of Directors may enact such rules and regulations for conduction of the business of the Society which do not conflict with the Constitution of By-Laws, Regulations of the Ohio Department of Agriculture, or laws of the State of Ohio. Rules and Regulations

- (1) Anyone who is 18 yrs. of age, and a member of Monroe County, can become a member of the Society upon the purchase of a membership certificate (ticket). Members are entitled to admission during the fair and shall be entitled
- to vote at the annual election of officers for said Society. (2) All articles and animals for competition must be in by Monday 9 a.m.,
- otherwise they will be excluded from competition. The Board will adhere strictly to the above rule for the name, age, sex, and description of the animal offered. (3) Animals to be entered in the name of the owner.
- (4) No person other than the judges will be permitted to get into the ring where the stock is exhibited, unless authorized by the superintendent in charge.
- (5) Cattle and sheep will be exhibited in the ring prepared for this purpose. The premium ribbons or cards will be presented before leaving the ring.
- (6) No premium will be awarded or paid on any article not mentioned or enumerated in this premium list.
- (7) The Board shall take every precaution in its power for the sale preservation of stock and articles on exhibition after their arrival and arrangement upon the grounds, but will not be responsible for any loss or damage that may occur.
- Exhibitors are expected to give attention to their articles and at the close of the fair (8) No animals or articles shall be removed until the committee determines date and time by each department, except Junior Fair livestock sold. Any
- violation of this regulation will result in a forfeit of the premium. (9) Awarding committees finding any article on exhibit not meritorious shall not award such stock or article any premium.
- No exhibitioner will be allowed to give or sell any article that will conflict with exhibitor's privilege.
- If there are not funds sufficient to pay all premiums allowed, after payment of other expenses, they will be prorated.
- All exhibitors, except Junior Fair exhibitors, shall be required to (12)purchase membership or season tickets.
- (13)Health certificates will be checked as livestock is unloaded. (14)
- Parents will be responsible for Junior Fair exhibitors staying overnight on fairground.
- (15)Smoking prohibited in any tent, building or shelter. (16)Junior Fair exhibitors will be required to pay entry fee when entering.
- Article VIII Annual Meeting of the Membership Section 1. The annual meeting of the members of the Society shall be held in the Henri Coulson Building on the second Thursday of October, 7 p.m.

Section 2. At this meeting, the officers and directors shall make reports to the society concerning the past fair and make recommendations for the betterment of future fairs. The members shall be given an opportunity to make suggestions and recommendations for the improvement of the society and its fair. Such other business may be presented as may be prescribed by this constitution or as may be deemed proper by the Board of Directors.

Article IX - Organization and Meetings

Section 1. The Board of Directors shall meet annually on the 2nd Thursday in October of each year and elect a President, Vice President, Secretary and

Treasurer. The term of office of the President, Vice President, and Treasurer shall be one year, and the Secretary term not more than three years or as the Board may determine and until their successors are elected and qualified. The President and Vice President shall be elected for two years not exceeding two consecutive terms.

Constitution Continued

Section 2. The President and Vice President shall be directors. The Secretary and Thursday of each month at 7 p.m. on the Monroe County Fairgrounds. the Treasurer may or may not be directors. (Designated by law).

Section 3. Before election of officers the newly elected directors will qualify by taking the following oath before a competent authority. (I do solemnly swear of affirm that I will support the Constitution of the United States, the Constitution of Ohio, Laws of Ohio, and the rules and regulations of the Department of Agriculture of Ohio pertaining to the Agriculture Societies and to the best of my ability perform the duties of director of the Monroe County Agriculture Society, so help me God.)

Article X - Amendments

Section 1. Amendments to the Constitution or By-Laws may be proposed by:

(A) A majority of the Board of Directors at a scheduled meeting voting in favor of placing an amendment on the ballot: or

(B) Filing a petition with the Secretary of the Society at least 14 days prior to the annual election of the Board of Directors. Said petition must set forth the proposed amendment and signed by not less than 35 members.

Section 2. If an amendment is proposed, it shall be submitted to the membership of the Society at the annual election of the Board of Directors or annual meeting. Section 3. When more than one amendment shall be submitted at the same time, they shall be submitted as to enable the members to vote on each amendment separately.

Section 4. If the majority of the membership voting on the proposed amendment shall adopt such an amendment, it shall become part of the Constitution or By-

Article XI - Fair Dates

Section 1. The Board of Directors shall fix the dates of the annual exposition of the society subject to the approval of the Ohio Director of Agriculture.

Article I - Quorum

Section 1. A majority of the members of the Board of Directors shall constitute a quorum for the transaction of business of the Society.

Article II - Meetings

Section 1. A regular meeting of the Board of Directors shall be held on the last

Section 2. The order of business MAY be temporarily suspended at any meeting upon a majority of vote of a quorum present.

Section 3. Written notice of special meetings of the Board of Directors shall be sent to each director by mail, telegram, or telephone at least two days before the meeting. (Such notice, however, may be waived by any director either before or after the meeting) The notice need not specify the purpose of the meeting. Article III - Order of Business Section 1.

Saddle Horse Rules

- 1. No horsing around in barns whips, ropes, water guns, laser lights, ect. are banned.
- 2. No flags hanging out over the walkways, if using curtains, secure them to the posts.

- 5. No teasing other animals or going into their stalls without owner's, advisor's, or parent's permission.
- 6. No tack, feed hay, wheelbarrows, ect. in the corners by small exit doors. Can use trailers or someone's campsite with their permission.
- 7. No turning horses loose in the arena (No Exceptions)
- 8. No parking of vehicles around barns, manure pit or down by the arena. Only one verbal warning will be given, then your vehicle will be towed at your expense.
- 9. Only 4-H necessities in the 4-H barn.
- 10. Entries must be turned in by the deadline shown in the fairbook for Open Class Show.
- 11. There will be a \$25.00 protest fee paid at the Secretary's office and complaint will be brought up in front of the entire fairboard
- 12. Must be 18 years old to show a stud. 4-H members must follow the uniform rules pertaining to the stallions. (stallions may be shown during the first calendar year in which it is born.)
- 13. Rules must be obeyed year-round.
- 14. No hay net bags.







(all commercial Ohio hatcheries meet this requirement) or,

B. Poultry are from a flock which has had a negative test for pen Pullorom Disease within 12 months, or

Entry fee - .50 cents per bird; \$1 per trio breeding pen. Open class entries must be in Aug. 2, 2021.

Rules and Regulations

Breeding pen (trio) one male and two females of the same variety. Exhibitors will be required to clean cages daily and also furnish their own feed and care for birds.

Only birds mentioned in the poultry section of this book may be entered in competition, unless agreed upon by building superin-

Birds entered singularly cannot compete in trio pens. Birds entered in trio pens cannot compete singularly.

Those making entries will be required to purchase a membership or season ticket (with exception of those with a 4-H pass).

Exhibitors must be the owner of the stock they exhibit. Combination exhibits will not be permitted

The term cock and hen refers to birds hatched prior to Jan. 1 of

the year of the fair. Cockerel and pullet refers to birds hatched after Jan. 1 of the year of fair.

Only poultry that has been exhibited and fees paid in full may be sold or traded on the fairgrounds and only after all exhibits have been judged.

Any exhibit removed early (even if sold or traded) will result in forfeiture of entire poultry premium.

No specimen will be allowed in the barn except that have been duly entered in competition and fees paid.

The board reserves the right to reject any or all entries.

Lights will be turned out and all doors locked at 10 p.m. This rule will be strictly enforced.

Every precaution will be taken to properly protect exhibits. Watchmen will be on duty in the building during the fair. The Agricultural Society will not be responsible for any loss. All Reserve Champion will be awarded. breeding exhibits released at 10:00 p.m. on Friday. All remaining after this time will be at the owners' risk.

- 6. The Superintendent of schools shall be responsible for the coordination of the exhibits. The principal of each school unit shall have exhibits posted in the School Exhibit Hall on Monday of the fair by 12 noon. The judging will be done by judges familiar with modern school methods and procedures. Judges may disqualify any exhibit not up to standards or that violates any rules. Seventh Department Hay and Silage

The Hay and Silage contest at the Monroe County Fair is sponsored by the Monroe Soil & Water Conservation District in cooperation with the Monroe County Agricultural Society and Heritage Co-Op.

The Hay/Silage samples will be pulled from a representative field/farm; not from single bales. Entries will be sent to determine the moisture, protein, ADF, NDF, and energy content. Entries will then be scored on feed value, to determine the class winners

Entry fee will be \$3.00 (a \$15 Value.) The participants and the SWCD will receive copies of the test results. (Results will be confidential and will only be used by the SWCD for ranking purposes.)

Entries will consist of core samples/samples 1 quart zip bag full, pulled from several bales (15 small square or large round) from the same field/farm. samples will be pulled with an approved core sampling tool, which can be obtained from the SWCD office, OSU extention or Heritage Co-Op. Small square bales and large round bales are combined in all hay classes. Hay classes will be mixed grass, clover or alfalfa. Silage classes will be corn silage or haylage.

Entries may be submitted to the Monroe SWCD at 117 North Main Street, 3rd Floor, Woodsfield, Ohio (Monroe Bank Building) beginning on Monday, August 16, 2021 and ending at noon on Thursday, August 19, 2021

Overall Hay Grand Champion and Silage Grand Champion will be selected and awarded at the SWCD annual meeting. Contact the Monroe SWCD at (740) 472-5477 with any questions.

2021 Junior Fairboard Constitution and By-Laws

(Revised January 2008)

ARTICLE I - TITLE

This organization shall be known as the Monroe County Junior Fair Board.

ARTICLE II - PURPOSE

The object of this organization will be to promote and encourage agriculture, industry, education, science, art and other interests of the youth of Monroe County, to increase the interest among youth groups for actively exhibiting at county fair time and to give them a voice in programs and policies toward improving the quality of the Monroe County Fair.

ARTICLE III - MEMBERSHIP

Membership shall consist of 30 members from any of the following Junior Fair Youth Organizations: 4-H, FFA, FHA, Boy Scouts, Girl Scouts, Juvenile Grange, Farm Bureau Youth and VICA.

- ARTICLE IV ORGANIZATION
 1. The members and officers of this organization shall at all times cooperate with and be under the supervision and direction of the Senior Fair Board in all matters pertaining to the Junior Fair Board
- 2. An Advisory Council shall consist of three representatives from the Senior Fair Board, the County 4-H Extension Agent, and at least one but not more than two adult advisors from each of the groups represented on the Junior Fair Board; however, 4-H will have four adult advisors.
- 3. All members and officers of this organization must have been members of their respective organizations for one year preceding their election and shall continue in such activity while serving on this board. Names of those enrolled must be recorded with the secretary.
- 4. Members present at regular or special meeting of which due notice has been given shall constitute a quorum for the transaction of business.
- 5. The Junior Fair Board shall meet for a minimum of 5 meetings per
- 6. All member's and officer's terms begin at their election, after the county fair, no later than March.


7. The Junior Fair Board will meet the third Thursday every month in the Extension Office.

ARTICLE V - OFFICERS

- 1. The Junior Fair Board shall meet each year to elect the following officers: President, Vice President, Secretary, Treasurer, News Reporter for a term of one year.
- 2. Duties of the President: The President shall preside at the meetings of the board, assign the Superintendents to the different departments, and see that the rules of the organization are enforced. The President shall also represent the Junior Fair Board at Senior Fair Board meetings.
- 3. Duties of the Vice President: The Vice President shall serve as a department Superintendent and shall assume the duties and responsibilities of the President in his/her absence. She/He shall bealternate representative to the Senior Fair Board in the absence of either President or Secretary.
- 4. Duties of the Secretary: The Secretary shall keep a record of all business of the organization, and represent the Junior Fair Board at Senior Fair Board Meetings.
- 5 Duties of the Treasurer: The Treasurer shall receive and take care of all money belonging to the Junior Fairboard and shall pay expenses upon action of the board; shall keep an accurate record of all receipts and expenditures. The Treasurer will co-sign checks with the Treasurer of the Monroe County Agricultural Society.
- 6. Duties of the News Reporter: The News Reporter shall write and deliver articles of Junior Fair Board News to the local news source.

ARTICLE IV - AMENDMENTS

This constitution may be altered at any regular meeting of the board when due notice of such alteration or amendment shall have been given at a regular meeting preceding and passed by a two-thirds vote of the members present.



(Order: Beef, Sheep, Swine, Goats, Dairy, Rabbits, & Poultry) Revised 2021

Registration, Ownership, & Possession

- *1. All Jr. Fair Exhibitors must submit a Jr. Fair Animal Registration to the OSU Extension Office by Monday, May 3, 2021 by 4:00 p.m.
- *2. Late Jr. fair animal registrations will be accepted with a fee until Thursday, May 13, 2021 at 4:30 p.m. A late fee of \$25 payable
- to the Jr. Fairboard will be charged for each animal entry turned in during the graceperiod (May 3- May 13 at 4:00p.m.). No entries will be accepted after 4::00 May 13th
 - 3. All Junior Fair Market Animal projects must be owned by the
- exhibitor or immediate family. 4. All Junior Fair breeding animals must be in the exhibitors care by June
- 5. Regularly enrolled members of Monroe County 4-H Clubs organ-ized and conducted under the supervision of The Ohio State University Extension be cleaned by 10:00 a.m. daily. Animals that are soiled are to be washed and Monroe County FFA members are eligible to exhibit in the junior fair

Quality Assurance Requirement

- 6. All Junior Fair Members exhibiting marketing animals, lactating
- dairy animals, or lactating goats MUST attend a quality assurance train-ing to participate in the Monroe County Junior Fair. Members under the age of 16 MUST attend the training with a parent or guardian. Members must attend one of the training sessions provided by the Monroe County Extension Office or a neighboring county in Ohio. Youth ages 12 and up (as of Jan. 1st) can
- opt to take a test rather than going through the quali-ty assurance session. *7. Quality assurance training, whether attended in Monroe County or another county, must be completed by July 1, 2021.

- 8. Exhibitors are required to follow the junior fair dress code.
- 9. Market animals must be exhibited in a market class in order to sell in the Junior Fair Livestock Sale.
- 10. If a market animal does not meet weight or market requirements the animal will be shown in an over and under weight class for their specie
- and their appropriate showmanship class. These animals will not be eligible for the championship or the market sale. 11. Members exhibiting market fryers or market rabbits must choose
- three animals to show from the pen of four on the day of weigh-in. If one of the three animals chosen becomes ill or otherwise unable to be used before the livestock sale, that animal may be replaced with the fourth animal from that pen, as long as the replacement animal met the weight requirement on weigh-in day.
 - 12. No Junior Fair female market animals can be shown in Junior Fair breeding classes.

 - 13. Parents and advisors are to remain in spectator area during judging.
- 14. Any current Monroe County 4-H or FFA member may assist another 4-H or FFA member with showing animals if that person has more than one (1) entry in a class, is sick, or is unable to show the animal due to other circumstances. Under no circumstance will a non-4-H or FFA member or
 - 15. Slick shearing of hogs is not permitted.
- 16. Regarding assistance in the care, grooming and preparation of junior fair livestock, exhibitors should refer to Ohio's Livestock Tampering Exhibition Rules (section 901-19-31) to verify who must be registered with the Junior Fairboard Office.

adult be permitted to show an animal in Junior Fair competition.

17. "For Sale" signs advertising animals are for sale are not permitted in the barns until Friday morning of the fair.

Showmanship Requirement

18. All Junior Fair exhibitors must participate in showmanship for each animal specie shown at the fair. If a member shows more than one specie and there is a schedule conflict, the member will choose which specie to show. Members not participating in showmanship will be disqualified from competing in market classes and selling in the Junior Fair Livestock Sale.

19. To encourage exhibitors to keep animal pens clean and animals properly fed the following policy will be enforced. Exhibitors will receive two written warnings before their premium is withheld. These warnings will be given by the Junior and Senior Barn Superintendents. The exhibitor's advisor will also be notified.

20. No health papers are required unless animals are moved or imported into Ohio for exhibition purposes. However, state guidelines must be followed. All animals must be free from contagious diseases.

21.All sheep and goats must have a USDA official Scrapie ear tag at the time of check in. 22.All medications given at the fair must be administered by the offi-

cial veterinarian or approved by the official fair veterinarian in writing to permit administration by Jr. Fair Exhibitors. 23 Animals are to be fed and watered at least twice a day. Stalls are to

promptly.

24. Locks are not permitted on any cage or stall.

25. There is to be no abuse of animals while exhibiting at the county

26. All Jr. Fair animals will remain on the fairgrounds until the specified time on Saturday of the fair unless released by the fair vet and/or the department superintendent. Anyone removing their animals without permission before the release times will forfeit their current premium and will not be permitted to show the following year.

Barn & Fairground Safety

are not to be tied and left unattended.

27. No dogs are allowed in the barns or on fairgrounds. 28. Animals are to be removed promptly from the wash racks. Animals

Junior Fair Showmanship Rules

1. All Junior Fair exhibitors <u>must participate</u> in showmanship for each animal specie shown at the fair. If a member shows more than one specie and there is a schedule conflict, the member will choose which specie to show. If an exhibitor does not participate in showmanship they are not permitted to show in market classes or sell animals in the Monroe County Jr. Fair Livestock Sale.

- 2. Showmanship classes will be shown before any breed classes or market classes.
- 3. Contestants must exhibit his or her own <u>Junior Fair</u> animal in each showmanship contest.
- 4. Showmanship Classes will be divided into the following age divsions and <u>all ages are as of January 1 of current year:</u>
 - For dairy, beef, dairy feeder, swine, goats, rabbits, sheep & poultry showmanship: Beginner Showmanship (*1st year exhibitors*); Junior Showmanship (*ages 9-11*); Intermediate (*ages 12-14*); Senior Showmanship (*ages 15 & over*); County Showmanship (*Current Junior, Intermediate, & Senior First Place Winners, Past Sr. Winners, Past County Winners, Past Supreme Showmanship Winners*).
 For Horse Showmanship: Beginners Showmanship (*1styear target alice and the state of the state*
 - exhibitors); Showmanship 9-11; Showmanship 12-14; Showmanship 15-18; County Showmanship (current first place winners of the following divisions: 9-11; 12-14; and 15-18).
- 5. Showmanship contests will be shown in the following order: Beginners Division followed by the Senior Division, Intermediate Division, Junior Division, and County Showmanship Division.
- 6. Any exhibitor who wins first place in the Junior Division will advance to the Intermediate Division and then to the Sr. Division the following year. Any exhibitor who is 1st place in the Sr. Division will advance to the County Division the following year. County and Supreme Showmanship winners will show in the County Contest the following year. (exception: Participation in Horse Showmanship Divisions are determined by age of exhibitor, not past winnings)
 7. Exhibitors are eligible to win the County and Supreme
- Shownanship contests more than once.
 - 8. Supreme Showmanship:
 - •All current county showmanship division winners (all species) will participate in supreme showmanship. If the county showmanship winner is unable to participate in the supreme showmanship contest, the second place county showmanship winner will participate.
 - Contestants will supply nine animals and the necessary show equipment for the contest, with the exception of poultry & rabbits who will provide one animal.
 - To assign animals to each contestant, there will be a random drawing to match animals with contestants.
 - Contestants will show all species, including the specie for which they are the county winner.
 - A judge for the contest will be secured by the Senior Fair Board.
 - Supreme showmanship winners have the option to participate in showmanship in future year.

*1.All 4-H Exhibitors must submit a Jr. Fair Horse Registration, along with two color pictures (must have) one side and one front view of his/ her horse, to the OSU Extension Office by May 3, 2021 by 4:00 p.m. A sign up form will be sent to everyone in July so you can sign up for what classes you will be participating in for each horse (DO NOT sign up for classes that you WILL NOT be participating in) Forms will be due back by July 16, 2021 to the Extension Office.

*2. Late Jr. Fair animal registrations will be accepted with a fee until **May 13, 2021** at 4:00 p.m. A late fee of \$25 payable to the Jr.

Fairboard will be charged for each animal entry turned in during the grace period (May 4 - May 13 at 4:00). No entries will be accepted after 4:00 p.m. on May 13.

- 3. 4-H'ers are permitted to register 3 horses for the fair. Members ages 8-14 may show a max of 2 horses at the fair. Members 15-18 may show 3 horses at the fair.
- line of May 3, including result of injury or death of the 4-H horse. 4-H properly fitted and in good condition. The Ohio 4-H Horse Program, members may complete the project by making an educational display or Show Committees, Officials, Extension Personnel, Monroe County poster that could be exhibited at the fair.
 - 5. A 4-H project horse may be used by only one member.
- 6. All horses taken as 4-H projects must be owned by the 4-H'er or immediate family (the "immediate family" being mother, father, brother, sister, grandparents, aunts, uncles, and step-parents) or leased by the member.
- *7. A horse may be leased when one or more of the following conditions exist:
- a. The youth does not have the financial ability to buy a horse. b. The youth has a horse, but it is unable to be used (lameness, pregnancy, too young, etc.)
 c. The youth has a horse, but it is of the wrong type for the edu-
- cational experience the youth wishes to obtain.

Leases must be for a minimum period of April 27 through end of county fair. A copy of the signed lease agreement is due April 27 by 4:00 p.m. to the Extension Office.

The MC 4-H Saddle Horse Committee will review lease agreements for eligibility at their April 30, 2021 meeting.

*8. All 4-H horse projects must be owned or leased and in the contin ual care of the 4-H member by May 3. Production animals must b owned by the member. Continual care does permit boarding an animal provided the member is involved in caring for the horse.

Helmets & Ethics

9. All youth age 19 and under, participating in any 4-H/Jr Fair equestrian activity, are required to wear properly fitted protective headgear which meets or exceeds current ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards with the chin harness securely fastened at all times while riding or driving an equine.

a) It is the responsibility of the rider, or the parent or guardian of the youth participant, to make sure the headgear worn complies with appro-*4. The project horse may not be changed after the registration dead-priate safety standards for headgear intended for equestrian use, and is Agricultural Society Directors and Volunteer Leaders are not responsible for checking headgear worn for such compliance.

> b) The Ohio 4-H Horse Program, Show Committees, Officials, Extension Personnel, Monroe County Ag Society Directors and Volunteer Leaders make no representation or warranty, expressed or implied, about any protective headgear, and cautions riders that death or serious injury may result despite wearing such headgear, as no helmet can protect against all foreseeable injuries in equestrian activities.

> c) The Ohio 4-H Horse Program, Show Committees, Officials, Extension Personnel and Volunteer Leaders may, at his/her discretion, check a participant's protective headgear for proper standards. If the youth is found to be wearing unapproved, defective, or improperly fitted headgear, he/she will not be permitted to participate in riding or driving activities until proper headgear is acquired.

- 10. 4-H members taking horses must complete a **one-time** safety and ethics program. This includes:
- a) The youth and parent/guardian must view two videos: Every Time

4-H & Junior Fair Saddle Horse Rules Continued

Every Ride and Horse, Kids, and Ethics;

b) Each 4-H'er and their parent must read the horse safety booklet, #191R and sign off that they have read it. One copy per family will be

- *11. The 4-H Saddle Horse Committee will provide a minimum of two clinics prior to the fair. Members must attend at least one clinic to be eligible to exhibit in the Monroe County Jr Fair Horse Show.
- Annually, the parent and youth must sign the OSU Extension Permission to Participate form.

- 13. Horse Nutrition and Horse Reproduction projects are separate projects and do not require taking a horse to the fair. These projects still require participation in Animal Skillathon Judging.
- 14. Lessons, instruction and advice for the member are encouraged. As long as the member is present in a learning situation, such assistance can include occasional riding or handling of the horse by another person, but cannot include regular training and care of the horse within 30 days of competition in any county state fair qualifying show or the state fair junior horse show. Showing a 4-H'ers project animal in a class at a show
- is not considered training. However, if a project animal is shown by someone other than the 4-H'er in an open or breed show within the 30 days prior to the 4-H competition, the 4-H'er must be present and have shown the project horse in that show.
- 15. Family members can ride a 4-H member's project horse without the 4-H member being present within the 30-day limit as long as it is not a daily occurrence and is merely for pleasure (i.e. trail riding with visiting relatives or friends) and does not include training of the horse for the show ring.

Showmanship & Showing

- 16. All Junior Fair exhibitors must participate in showmanship for each animal specie shown at the fair. If a member shows more than one animal specie and there is a schedule conflict, the member will choose which specie to show.
- 17. Regularly enrolled members of Monroe County 4-H Clubs organized and conducted under the supervision of the Ohio State University Extension and Monroe County FFA members are eligible to exhibit in the junior fair department.
- 18. For the Junior Fair Shows, a horse project can only be shown by the Jr. Fair Exhibitor enrolled in 4-H for that horse. Exhibitors can show

only one horse per Junior Fair Class.
19. All animals must be led to and from the ring area.

- 20. Members are to ride horses only in arena and designated warm up area. Members are to lead animals to arena area. No horses are to be between barns and racetrack, or around bleachers, or in camping area.
- 21. During the county fair, exercising will be done only with adult permission and supervision, preferably an advisor or parent from the exhibitor's club.
- 22. Beginner Classes are for members showing horses for the **first time** in that specific class in the Jr. Fair. Beginners may also show in their appropriate age division if capable of class requirements
- 23. No professional trainers, advisors, or parents will be permitted to stand along the rail or coach 4-H members while showing. Examples: no electronic devices, hand or verbal signals.
- 24. Whether a horse has a roached, banded or full flowing mane should not count in judging as long as it is clean, free from tangles and neatly trimmed.

Health, Safety, Care

- 25. It is required that a 4 or 5 way vaccination be given to horses at least 30 days before the fair. A receipt must be shown at fair check-in.
- 26. While at the fair, horses are to be fed and watered before 9:00 a.m. and again by 6:00 p.m. Feed pans are to be removed after feeding or securely fastened.
- 27. All medications given at the fair must be administered by the official veterinarian or approved by the official fair veterinarian in writing to permit administration by Jr. Fair Exhibitors.

- 28. 4-H project horses deemed dangerous must be evaluated by the advisor and 4-H Saddle Horse Executive Committee to report back to the 4-H Saddle Horse Committee, recommending precautionary actions or eligibility to be shown as a 4-H Saddle Horse in the Jr. Fair Show.
- 29. Any horse that is a known "kicker" must have a red ribbon in its tail at all times. No net hay bags.
 - 30. There is to be no abuse of horses while exhibiting at the fair.
 - 31. Horses are to be groomed & their stalls cleaned regularly.
- 32. No riding or clipping of horses will be permitted in the barn. main aisle must be kept clear at all times.

State Fair (see the most current State Rules for more details)

- *33. May 3 is the final deadline to sign up for State Fair Tryouts.
- 34. If a horse is leased, the lease is to be in the Extension Office by

April 27 at 4:00 p.m.

- 35. A youth must qualify in two classes in order to go to state fair. If they qualify in more than two classes, the youth can select which classes (miximum of three, not including ground roping or maximum of four if including ground roping) they will enter in the State Fair Junior Horse Show.
- 36. A youth may only use one horse to try out in PAS shows and cannnot replace a horse for any reason after they have shown in their first PAS class.
- 37. 4-H members wishing to tryout for the State Fair must have attended four (4) of their six (6) required meetings by the tryout event.
- 38. State Fair Participants must exhibit and show their qualifying horse

at the Monroe County Fair in one of their qualifying classes (if offered) to be recognized and received a county trophy, unless excused by the approved fair veterinarian. Any 4-H'er that goes to the Ohio State Fair and does not bring their horse to the Monroe County Fair is disqualified from trying out for the Ohio State Fair the following year.

Clean-up

- *39. Horses will not be released to go home until 12:00 p.m. on Saturday of the fair. If removed early you will not be allowed to show the next year.
- 40. After horses are removed at the end of the fair, each exhibitor is responsible for cleaning the stalls used for their horse. Uniform Rules
- 41. These rules are to be used with the publication "Uniform Rules for
 - 4-H Horse Shows", 4-H and Junior Fair Horse Shows will be governed by the rules in the "Uniform Rules for 4-H Horse Shows in Ohio" book.

Jr. Fair Livestock Sale Committee Constitution & By-Laws

ARTICLE I: TITLE

The name of this group shall be known as the Monroe County Junior Fair Livestock Sale Committee, hereafter referred to as the Sale Committee.

The purpose of the Sale Committee is to promote and manage the Jr. Fair

ARTICLE II: PURPOSE

Livestock Sale at the Monroe County Fair. The Sale Committee shall be responsible for determining and enforcing the rules and regulations that govern the Jr. Fair Livestock Sale.

ARTICLE III: RESPONSIBILITIES AND DUTIES

The responsibilities of the Sale Committee shall be:

- 1. To select and secure auctioneers, clerks and ring men.
- 2. To select final terminals for consigned livestock and assist in loading and shipping animals.
- 3. To collect proceeds from the sale and disperse proceeds to recipients.
- 4. To maintain accurate bookkeeping and financial records as needed. Books will be subject to a yearly audit as required.
 - 5. For the recognition of buyers. 6. For the expenses incurred by the sale committee for the sale.
- 7. To set up the sale ring.
- 8. To establish the time and date of the sale in cooperation with the
- Senior Fairboard 9. To aid in promoting and securing livestock buyers.
- 10. To advertise and promote the livestock sale.
- 11. To determine order of the sale.
- 12. Conduct large and small animal weigh-in and record the appropri-
- ate weights. 13. To secure a photographer for the sale.
- 14. To establish and enforce procedures and rules for making entries for
- the Livestock Sale and for conducting the Livestock Sale.
- ARTICLE IV: MEMBERSHIP
- Section 1:

The Sale Committee shall consist of the following voting members: **A**. Twelve at-large members who are knowledgeable about the various

- livestock project areas. **B**. Two Junior Fairboard Members who are to be appointed each year
- C. One representative from the Monroe County Senior Fairboard.
- **D.** Ex-officio members (who do not have voting privileges) will include:
- The 4-H Extension Educator
 - The Agricultural Extension Educator One county Vo-Ag teacher who is involved with market
 - livestock production projects.
 - One member of the 4-H Advisory Committee selected annually by the Advisory Committee.
- E. Honorary members (who do not have voting privileges) will include past Monroe County Junior Fair Livestock Sale Committee members that
- have served a minimum of 20 years. Section 2:

At-large committee members shall serve three year terms on a rotating basis. Terms will be staggered to permit the election of three members each year. At the end of a full term, the at-large member may apply for re-application to the committee.

In the event a member is absent four consecutive meetings, the remaining members shall select a replacement.

In the event an at-large member decides not to continue on the sale committee after their three year term, the committee will appoint a new member.

Section 5: All members appointed annually will serve a term from Jan. 1 to Dec. 31.

All unexpired or unfulfilled terms shall be filled by appointment of the Sale Committee.

Section 7: New members shall assume their duties at the January meeting.

Section 8:

All meetings are open to interested persons but only voting members are able to cast a vote.

ARTICLE V: ORGANIZATION

Members present at a regular or special meeting of which due notice has been given shall constitute a quorum for the transaction of business provided and number is not less than five. Motions can be approved with a majority of voting members present. **Section 2:**

The Sale Committee will hold its regular meetings on the second Tuesday in the months of January, March, May, July, August, September and October.

Section 3:

Special meetings may be called by the President as deemed necessary. Section 4: Conduction of the meeting will be informal. However, Roberts Rules of

Order shall govern the meetings of the Sale Committee to insure the orderly transaction of business.

ARTICLE VI: OFFICERS The officers of the Sale Committee shall be President, Vice President,

Secretary, Treasurer and Co-Treasurer. These officers shall be elected annually from the at-large membership at the January re-organizational meeting by the voting representatives present. The President, Vice-President, Secretary, Treasurer and Co-Treasurer will be known as the Executive Committee.

Junior Fair Livestock Sale Rules

- 1. Members of a Junior Fair Organization (4-H. FFA) may participate in the Jr. Fair Livestock Sale.
- 2. Members may sell livestock in any of the following categories, but are limited to only two trips through the sale ring.

- D. Feeder Calf Steer E Dairy Feeder F. Market Lamb

- * If the Ohio Department of Agriculture bans poultry exhibitions in Ohio for current year, youth will not be permitted to exhibit or sell poultry displays at the Monroe County Fair.
- *3. Members deciding not to sell their animals, including hogs, must notify the Jr Fair Office in writing by 12:00 noon Wednesday of the fair. Any exhibitor (or family member) who harasses a buyer after the purchase of animal and requests to have the animal given or sold back to them will be banned from selling any Junior Fair Market animal the following year.
- 4. All Grand Champions and Reserve Champions are required to sell providing all requirements have been met, such as weight requirements, and all other Jr. Fair Rules, Jr. Fair Sale Committee Rules, 4-H Rules and FFA Rules. In the event any exhibitor has more than two champions (over-all grand or reserve), the exhibitor must decide which two they will sell; anything above those two, designated as
- Grand and Reserve Champion animals are designated as terminal and must go to slaughter: market steers, market hogs, market lambs and market wether 5. According to Jr Fair Showmanship Rules, showmanship is required. If an

terminal, would go to slaughter or resale to an approved facility according to Ohio Department of Agriculture regulations. The following

- exhibitor does not participate in showmanship they are not permitted to sell animals in the Monroe County Jr Fair Livestock Sale.
- 6. Sales will be Thursday of the Fair. Care of the animals will remain the responsibility of the members until the animals are removed from the fairgrounds. Animals become the property of the buyers at the time of the sale.
- The Junior Fair Livestock Committee will provide one-way transportation only for animals sold through the sales. The Committee is not responsible for transporting non-sale animals.

Animals are to be weighed clean and dry with only one halter. The weightmasters have the
- right to refuse to weigh any animal that is deemed to be not clean and dry. Animals will only be weighed and hip heighted once at the following designated times. The order of weigh in for the four bovine groups will be rotated each year with the first group moving to last for the following year. For **2021**, the order will be as follows: Monday, 9:00 a.m. - Fryers, Rabbits, Ducks Monday, 9:00 a.m. - Turkeys, Market Wethers, Meat Does, Lambs,
- Market Steers, Dairy Feeders, Feeder Calf Heifers, Feeder Calf Steers Tuesday, 8:30 a.m. - Hogs
- 9.All tags, except Monroe County Assigned Tags, USDA Scrapie tags, or National ID tags must be removed prior to weigh-in or will be removed at weigh-in. 10. No outside scales may be brought onto the fairgrounds. "Official"
- fairground scales may only be used by designated officials. 11. For market sale purposes animals will be exhibited by weight
- classes. Classes will be as follows:
- animals, min of 1 class 7-11 animals, min of 2 classes
- 12-20 animals, min of 3 classes
- 21-30 animals, min of 4 classes 31-40 animals, min of 5 classes

- Market steer classes will be determined by the number of steers to be exhibited, with a maximum of 5 steers per class & a minimum 3 classes

- 13. The Jr. Fair Livestock Committee, in consultation with the "approved veterinarian" assigned to the Fair, has authority to disqualify any animal from selling that is sick or unsound. All medications must be administered by the offical fair veterinarian. If a carcass is condemned due to tampering, abuse, or drugs the exhibitor will be turned over to the Ohio Department of Agriculture.
- *14. All livestock projects must be registered on Jr. Fair Livestock Registration Forms and returned to the Ohio State University Extension Office by 4:00 p.m. Monday, May 3, 2021. Late registrations are not permitted and will prevent Junior Fair members from exhibiting in junior fair classes and selling in the junior fair market sales.

*15. Animal ear tags and poultry bands will be assigned and

provided by the Livestock Sale Committee after the May 3rd

- registration deadline. Hog ear tags, poultry leg bands, and rabbit tattoo numbers will be distributed to 4-H and FFA members. Feeder calf heifers, feeder calf steers, dairy feeders, market lambs, and market goats will be tagged on May 16th at the fairgrounds. The Sale Committee will randomly spot check members for possession of animals and that animals have been properly tagged, banded, or tattooed. Anyone knowingly switching or replacing animals after the possession deadlines will be disqualified from selling in the Jr. Fair
- 16. All decisions of the Junior Fair Livestock Sale Committee are finalized by the Monroe County Senior Fairboard.

- 4. Exhibitors may tattoo and weigh-in up to 3 rabbits per pen. At weigh-in, exhibitiors will select 2 rabbits to make up the pen of 2.
- 5. Market rabbits are a terminal project. All market rabbits brought to the fair and weighed-in will be taken to slaughter with arrangements made by the sale committee.

MARKET FRYERS

1. Must be registered by May 3, 2021 and in members continual care by Monday, July 13. 2. All fryers must be banded with bands provided by the Livestock Committee. 3. Fryers must be of a meat type bird and weigh between 4 and 7 pounds (weights are inclusive) at weigh-in to sell. 4. Market hogs must be ear tagged and in the members continual care by June 1st. 3. 3. Exhibitors will be responsible for tagging their own market hogs and turning in an identification card, photo of the pig with the tag in their ear by June 5, 2021. Tags, ID cards and information will be available at the Extention Office after May 3. When turning in pictures of the tag in the hogs ear, exhibitors should get a picture of the tag in the ear and picture should show color markings or ear notches if possible. 4. Only two market hogs can be brought/exhibited at the fair. 5. Market hogs must weigh between 220 and 300 at fair weigh-in to sell.

Barrows or gilts will be accepted. 7. The market hog sale is terminal. All hogs sold through the Jr. Fair Livestock Sale must go to a slaughter or resale facility. 




